### **EDUCATION**

#### 2001-2005

- I attended the Law Faculty "Nicolae Titulescu" at the University of Craiova.
- In the 4 years I had an average of 9.934.
- During the second half of the second year, from February and until June, I was the beneficiary of a scholarship with the Socrates/Erasmus Program. During this period I studied in France, at the University of Dijon, where I attended the Public Rights class, International Public Law, Intensive International Public Law, a workshop in Public Rights and a class of International Political Analysis.
- I chose as the theme for my thesis the European Union, with a focus on the judicial system. I compared the Court of Justice of the European Union with the European Court of Human Rights.
- I graduated my final exam as head of my class with a mark of 9.93.

## 2001-2005

- I attended the Letters Faculty at the University of Craiova.
- My major was in English and Italian grammar.
- I finished with a mark on my final exam of 10.

- 2001-2005 I was the Law Faculty Students' Delegate in the University Senate, in the Law Faculty "Nicolae Titulescu" Teachers' Council and in the Students' Organizations Convention in Craiova. As our faculty students' representative I have the opportunity to work with all the representatives from the other faculties to organize different events on an academical and social level.
- In November 2002 I, together with many of my colleagues, won the HEXAGON, a competition between the 6 best Law Faculties in Romania.
- From October 2003 and until September 2004 I was the Vice-President of the European Law Students' Association in Craiova (ELSA Craiova) and in this position I organized several conferences and even a local Moot Court Competition on civil law. In ELSA I took part in several national meetings and study visits with law students from all over Romania.
- In the summer of 2004 I attended the Neuwaldegg Seminar in Vienna, Austria, a seminar organized by the Educational Initiative for Central and Eastern Europe. As the representative of the Law Faculty within Craiova University, I attended, among others, the class of Ethics and of International Politics.

- 9 December 2005 I took part in the symposium organized on the 60th anniversary of the signing of the UN Charter. The event was put together by the Romanian Institute for Human Rifgts, the Comission for Human Rights, Cults and National Minority Problems within the House of Representatives and the Comission for Human Rights, Cults and Minorities within the Senate. The theme of the event was "The Evolution of Human Rights at 60 years from the adoption of the UN Charter, selebrating also Human Rights Day on the 10th of December.
